The Beach City Council met for a Regular Meeting and a Public Hearing on Tuesday, June 25, 2013 at the Beach City Community Building. Those present were:

I. Call to order:

Mayor Combs called the meeting to order Tuesday June 25, 2013 at 6:01 pm. Alderman Colquitt offered prayer and led the Pledge of Allegiance to the United States and Texas flags.

IV. Hear report and update from Chambers County Commissioner, Rusty Senac.

Commissioner Senac commented on the two nuisance complaints that Chambers County has been working on for many months. One home has complied with the County. The home located at 8521 Ocean Drive has not complied with the County's request to clean up the property and the County is reevaluating its plan of action. Secretary Donnelly will resubmit another nuisance complaint to Chambers County regarding the dilapidated condition of 8521 Ocean Drive.

Mayor Combs and Commissioner Senac discussed the condition of

the Enderli property in Walker Subdivision and will speak again in a few days to discuss a plan of action to get it cleaned up. Commissioner Senac informed Council of Mayor Combs and Secretary Donnelly's request for the County to repaint the outside of the community building, the City office and the Fire Station. The City Office will also get new flooring; the beautification project is scheduled for sometime in July.

Mayor Combs asked the Commissioner if the City purchases lights for the flag pole will the County install the lights; Commissioner Senac replied, yes.

On FM 2354 and Fishers Rd. dump trucks are being ticketed for being overweight and speeding. The Sheriff's department has been trying to address this issue and DPS has been patrolling as well. Sheriff Hawthorne gave an update on the new definition of a vicious dog: Any dog that shows aggression, and is not on a leash or behind a fence.

The Sheriff's department has received a grant for two new airboats and there will now be a deputy patrol on the water.

V. Hear report and update from Beach City VFD.

Beach City VFD Chief Robert Campise gave the Council and Mayor a copy of their approved working budget for Fiscal Year 2013/2014. The BCVFD hopes to be able to purchase a set of Hydraulic Rescue Tools (Jaws of Life, ramps, cutters, spreaders, etc.) that work better with the neighboring fire departments. The current tools are good but do not work well with the newer tools used by the other fire departments.

Alderman Newman politely suggested to Chief Campise that they plan on doing a fundraising mail out to the residents. The Chief agreed that the BCVFD needs to do a mail out.

The City will be doing a survey in the near future and Mayor Combs suggested the BCVFD do a merged mail out with the City to save money on postage. Chief Campise will speak to the Mayor at a later date to discuss that possibility.

Mayor Combs has purchased some electronic items for the office: a new computer, which is being built; a new shredder; and a projector to be used in our workshops. These items show up under the Mayor's Expenses.

Next month's meeting would require an amendment for the Beach City Volunteer Fire Department.
